Who Should Attend?

Qualified Credential Requirement

To apply for the CSP, candidate must have either ASP / GSP / TSP / CIH / CMIOSH / CRSP / NEBOSH Diploma. (Not Required for ASP)

The ASP examination is the same but covers 7 domains and only time allowed is 5 hours.

Test Formats	Computer-Based: After the exam is purchased, you will receive an examination authorization notice that is used to schedule the exam through Pearson VUE testing centers. Examinations are delivered via computer.
Test Result	As soon as candidates submit their exam, results are available. Once you pass the examination BCSP will reward you with your earned certification.
